**February 2014 until present.**

**Commenced as full time lecturer at the MFU Medical school. My main role being to teach medical English and also to help students to understand how the science translates to clinical medicine.**

**July 2012 until December 2013.**

**I completed my final ship contract and in January 2014 accepted a post of lecturer at Mae Fah Luang University Medical School, commencing late February.**

**April 2010 to March 2012.**

**I completed a two year contract at the Cheshire Hall Hospital in Providenciales, Turks and Caicos Islands. This is a private finance initiative for the TCI government, the hospital being managed by Interhealth Canada, a company with worldwide experience in hospital management. The post was a combination of family practice and emergency department duties. Prior to the hospital being opened care on the island was provided mostly on a private basis inside a small government building that had limited facilities. Care is now via a government levied insurance, qualifying much of the population to receive subsidised medical care of a high standard. The hospital has MRI/CT/mammography plus state of the art operating and high dependency ward facilities. The laboratory can provide most necessary services in house. This change of medical care provision uncovered a huge amount of unmet need and neglected pathology, resulting in a huge work load dealing with chronic illness, particularly hypertension and diabetes, along side a large volume of major trauma due to violence and to road traffic accidents.**

**In August 2010 I was appointed Head of Family Practice and helped develop the department to provide a flexible but focused pattern of ongoing care and helped lead the department through a process of international accreditation with Accreditation Canada International, achieving Diamond Level.**

**The combination of ED and family practice kept my skills up to date as well as maintaining current ATLS/ACLS certification. Since August 2010 the hospital has hosted medical students from McGill University, Ontario and also from Cambridge and Bristol in**

**the UK. I enjoyed helping the students to develop their clinical skills and insights into the art of medical diagnosis and communication with patients.**

**In February 2012 I completed a medical ultrasound course to update and refine my understanding of this modality.**

**February 2005- 2010.**

**In March 2005 I commenced work as a ship physician with Carnival Cruise Lines CCL. Initially on M/S Fascination, a single doctor ship.**

**October 30th 2005.**

**Appointed as a Senior Ship Physician, covering the larger ships. The infirmary had a staff of 2 doctors and 4 nurses. We looked after a crew of 1200, acting both as their family and occupational practice. We normally carried 3500 passengers. We dealt with whatever medical problems arose on board from lost tablets to major trauma and cardiovascular events. My duties were also those of a senior ship's officer and head of department. My contract on board was for 4 months followed by a 2 month lay off.**

**2000 to 2007.**

**I worked part time as a clinical assistant in the emergency department in Bradford to maintain skill levels, and meet old friends!**

**April 2008 to December 2009.**

**During my downtime I worked part time as a general physician at Inter Island Medical Services, Grace Bay. TCI. This is a private practice dealing with a full range of acute and family medicine, with its own X-ray facility and resuscitation suite.**

**1976-1980.**

**House jobs then SHO surgical rotation until March 1980 at Bradford Royal Infirmary. A busy rotation with a lot of hands on experience.**

**1980-1995.**

**Clinical assistant in the ER at Bradford Royal Infirmary, working regular weekly sessions. I restarted sessions Oct/Nov 2004 following regaining ALS certification.**

**1980-2000.**

**Principal in General Practice. Inner city practice - 5 partners and 12000 patients. Good clinical experience and I was initially referred much of the orthopaedic cases.**

**Elected on to Local Medical Committee from 1991.**

**Participated in teaching local 4<sup>th</sup> year medical students, introducing them to Primary Care**

**Fundholding lead partner. Helped form a large commissioning group which went on to be a Gold Standard Organisation .**

**Locum to the Independent Medical Advisor to the Family Health Services Authority.**

**Deputising Liason Officer, helping to monitor out of hours services.**

**Redeveloped practice premises, one via cost rent and other via a Government re-Financing Initiative.**

**2000-Feb 2005.**

**Partner in Park House Private Practice. An acute presentation type general practice, occupational, medico-legal, slimming, botox and collagen.**

**2001-March 2005.**

**Government Health Safety Executive Examiner of Divers. I have a good understanding of diving/ hyper-baric medicine but no formal qualifications as this was not relevant to my work at that time.**

**1995-March 2005.**

**Appointed Doctor for local Lead related industries.**

**1980-Feb 2005.**

**Medical Officer to Alhambra theatre. I dealt with medical issues related to the Northern Ballet Company and many of the stage performers.**

**1978-1996.**

**Doctor to Motor Racing Services holding full rescue licence and pre hospital trauma experience. At this time pre-hospital care was in its' infancy and I was involved in much of the hands on innovation that is now standard practice. We had one of the first scoop stretchers and pre-production generator-hydraulic 'Jaws of Life'.**

**1986-1991.**

**Active as Captain RAMC 212 Field Hospital. Held ATLS during that time. Attached to 23.SAS from 1988. I learnt to jump out of perfectly good planes and lived to tell the tale! I was also taught good organisational skills, a great deal about triage and management of mass casualty situations in difficult circumstances.**

**1998-2011.**

**PADI Asst Instructor and regular diver - Dry suit in the UK – around the Farne islands - cold and 5m swell! as well as warm water diving world wide.**

**BLS, PALS, ACLS current.**

**HIV/Hep status/VDRL negative, again regularly checked. I take amlodipine and atenolol for control of raised blood pressure. No other problems other than occasional hayfever and related urticaria/ shell fish allergy. I take loratidine to control this as necessary. Not usually a problem in warm climates - different pollen etc.**
